Kennedy Assassination Records Collection Act of 1992 (Public Law 102-526) (JFK Act) related to the status and disposition of the original film of the assassination by amateur photographer Abraham Zapruder.The original film was purchased by Time-Life for \$150,000 shortly after the assassination of President Kennedy. Mr. Zapruder donated \$25,000 of this amount to a fund to benefit the family of murdered Dallas Police Officer J. D. Tippit, allegedly killed by Lee Harvey Oswald after the assassination. Time-Life sold the film back to the family for \$1.00 in 1975. The film was placed in the National Archives in 1978.
