_____ Previous information indicates subject was at one time "violently pro-Castro, wealthy & the successor to Arcacha Smith as head of the New Orleans branch of the Cuban Revolutionary Council (an anti-Castro organization). He was associated w/Meterie, LA in appx 1963. New information indicates subject known as "Frank A. Bartes" was born 09.14.1920, died 02.24.1997 & had ssn 436.68.1569 which was issued in Louisiana during 1963. In 1986, a source indicated his employment as "retired". He was appx 5'09" & his last address was: 1918 Olive Avenue in Sebring, Florida 33870. This is a single family home which lists Frank & Esperanza Bartes as owners. Bartes' information associates him w/the following locations over the past few years:
