Moore, Jr., USA (DAPA-ZXI)Description of the Call Date: 06/24/97Subject: Colonel Moore Called Doug Horne and David MarwellSummary of the Call:Colonel Moore, the Army's new Compliance Official, called David Marwell today to introduce himself and ask for an update on any concerns we might have about the ongoing processes in which we are involved with the Army. After exchanging greetings, David Marwell passed him to me to discuss specific issues in more detail.I discussed the following issues with Colonel Moore:-The initial review efforts involving the Califano papers, which involved Army Declassification Agency employee Ms. Toni Bowie;-The strategy for the upcoming mass declassification session involving both the Califano and Joint Staff/JCS Papers the week of July 21;-Other Army efforts of which he was unaware, namely: significant portions of the IRR file on Richard Case Nagell--which are mired in the DAIG office awaiting declassification review, and portions of the IRR file on Clemard Joseph Charles--which are undergoing declassification review by Bert Haggett, in DCSI's office.-The requirement for RIFs, of which he was unaware.I promised that ARRB would facilitate his receipt of RIF discs from NARA, and he in turn said he would pass implementation of the RIF tasking onto Pat Smith, who is his point man on matters pertaining to the JFK Act. Colonel Moore encouraged us to call him with any problems or concerns we have in the future. ENDDon't forget to compose individual Action Item documents for any action items that resulted from the call!
