**Subject:** Military Team Weekly Update for the Period Wednesday, June 18-Tuesday, June 24

DIA:ARRB received from DIA on July 24 the results of their declassification review of the 17 PTC telexes passed to them by Joe Masih for review at our May 14 meeting at DIA. Of the 17 documents, 14 were designated "release in full," 1 had some requested postponements, and 3 have CIA equities. Bob Skwirot will be passing these 3 to the CIA's HRG soon for review. After their return to ARRB, these 3 will be entered into review track. I prepared a list of topics to discuss with the DIA compliance official, Anne Winner. I intend to call her this week. NSA: Our working level P.O.C. at NSA will be retiring from civil service on August 1, and Christopher (our NSA expert) will be leaving late in July. Accordingly, Christopher called his NSA counterpart and scheduled a turnover meeting between concerned NSA personnel and concerned ARRB personnel for 10:30 A.M. on Wednesday, July 16. NSA invited us out there, but I am inclined at this point to have the meeting here if we can get them to agree. Kevin has expressed an interest in attending also. Mass Declassification Session for Califano and JCS Papers: The Army, the Joint Staff, and NSC have indicated telephonically that they want to play. We have not heard yet from State (probably a function of Nina Noring being on vacation) or CIA. My intention is to send out fax memos next week which will notify all parties that the session is firmly scheduled for the week of July 21, and invite them to RSVP with names of attendees and clearances. Christopher has coordinated with Ed McBride of the Joint Staff (their compliance official), and Ed has indicated that he wants to send over two of his people ("can do" types) ahead of time to conduct declassification review on the 146 Joint Staff documents ahead of time, so that when the group declassification activity begins, they can concentrate on the Califano Papers, and other agencies may not have to look at some of the 146 Joint Staff documents if those have been released in full already. I strongly support this desire of the Joint Staff to come over ahead of time and review their own papers first, since it should streamline the group session a bit. Noblesville High School Interns: On Wednesday, Christopher completed the third of three days of intern activity. Subsequently, he gathered together and submitted to Jeremy their working notes on what they flagged during review of Church Committee files, FBI files on Roselli and Giancana, and CIA papers on the Guatemala Coup in 1954.
