Call Date: 07/29/97Subject: Doug Horne Called Elaine Rogic at IRRSummary of the Call:I called Elaine Rogic to  
inform her that Mr. Jim Goslee was starting next week at ARRB, and that pursuit of outstanding IRR referrals  
would be his primary assignment. She said that her new Commanding Officer, Lt. Col. Bisacre, wanted to meet  
with me to get an overview of the outstanding business between IRR and the ARRB. I told her that was fine,  
but that I wanted to give Jim Goslee a couple of weeks to get his feet on the ground first. She proposed, and I  
agreed to, a tentative meeting date of August 20, 1997, at 1:30 P.M., for Jim Goslee and I to meet with her  
and Lt. Col. Bisacre. She will check with his secretary and confirm actual time and date later.She said her C.O.  
still wants to receive a letter from David Marwell which (1) assures IRR that ARRB has assumed responsibility  
for pursuing the 34 IRR HSCA sequestered collection referrals [thus giving him a comfort factor that we will  
not come back at them later and blame them for inactivitiy in this area], and (2) establishes a revised,  
extended deadline for the completion of our business with IRR.Based on an earlier voice mail from her, it was  
clear to me that IRR did not understand that ARRB is the conduit by which original records must be  
transmitted to NARA (along with the final redacted versions following Review Board approval of requested  
agency postponements). I did my best to explain to her the complete process of document review, Review  
Board consideration, and final transmission of both originals and final redactions to the Archives (via ARRB).  
She said this was all news to her, that no one at ARRB had ever explained this to her before; she had been  
assuming that her agency had the right and sole responsibility of transferring originals to NARA because that  
was what she had always done under FOIA. She listened attentively to my explanation and, I believe,  
understood.Left unresolved was whether IRR would keep originals until the end of the review process, or  
whether they would relinquish the originals to us early (and pass responsibility for marrying up referrals and  
originals to ARRB staff). This is an important question which must be resolved soon, since we need to be able  
to tell agencies holding IRR referrals whether to send them back to IRR, or directly to us, after completion of  
review. She said that some agencies to whom IRR had sent HSCA sequestered collection referrals had  
responded already (i.e., IRR had received some referrals back following the referral agency's declassification  
review). I asked her to fax that information to me so that I could provide this information to Jim Goslee before  
he begins pursuing delinquent referrals.Finally, I asked her to reassemble, to the maximum extent possible,  
IRR's correspondence file regarding these HSCA sequestered collection referrals, and to pass it to us at our  
meeting with IRR later in August, so that ARRB could use these at starting points for our discussions with
