Phillips formerly w/ USSS Protective Research Section (PRS)Description of the Call BACKGROUNDARRB efforts to trace the history of the Z-Film led us to work done w/in the National Photographic Interpretation Center (NPIC). In 1963, NPIC was part of the CIA's Science & Technology Section. ARRB has interviewed 2 former NPIC employees who performed analysis/enlargement of Z-Film frames. These interviews led us to the possibility of a USSS Agent (who possibly identified himself as "Bill Smith") involved w/transport of the film & possible film work performed in Rochester, NY. ARRB identified a box for Kodachrome movie film (labeled "0186") at NARA w/markings stating the film came from "A. Zapruder" & the name Max Phillips is present as well; we have reason to believe Phillips may be "Smith".BODYI located & spoke w/ a Phillips today who confirmed he worked w/the USSS for appx 30 years. After I explained the nature of the Review Board & our efforts to obtain as much as possible for the JFK Collection, Phillips (who was cordial) jokingly asked why we don't use our vast power to make Oliver Stone tell us the truth; after a pause, he described Stone as a "...24 carat jerk-off...". Phillips asked several times about our stratification & our sunset date. He'd like to receive some material about us before making any statements, saying "...I've been in the business long enough to know I should be smarter than that...". Phillips asked if an in-depth interview would be done "eyeball-to-eyeball", to which I said I'm not sure given our resources, but that we are indeed empowered to find all records. Phillips said he understands & will cooperate after he receives an info packet. Phillips joked as to how I knew where he was since he just moved this month, to which I reminded him he was in the business for some time; he laughed & said he did the same thing when he was "in". Phillips asked for my name, title & phone number, then he thanked me for the call & said he looks forward to hearing from us. I verified his information, thanked him for his time & ended the call.
