I visited the Library last year & made copies of the following Collection indexes:-Richard Billings Collection-Richard E. Sprague Collection-R.B. Cutler Collection-"A Guide To The Microfilm Edition For The FBI Files On The Assassination Of President Kennedy" (we've transferred appx 90,000 pages to our scif of FOIA request information dealing which correspond to this guide)-general catalog for all of Georgetown University's Special Collection materialLizette checked & confirmed that the only restriction she can find for any JFK related collection is re: the Richard Billings Collection. The photos are restricted at the request of Time/Warner due to an incident involving a photo & a researcher. All of the material (including photos) can be reviewed by the public, but no reproductions are allowed w/out the approval of Time/Warner.The index (for which we have a copy) gives a history of Billings as a photographer w/Life Magazine who covered the Garrison Investigation.
