Glynn in TRIANGLE, VA. The operator said he was not permitted to give me either the street address or the telephone number.So...please go back to FINCEN Monday or Tuesday and try to get a current address and telephone number on this individual. I would like to be able to call him next Wednesday morning, if at all possible, discuss his contact with the HSCA with him, and then invite him to come up on the 17th of September to meet with Kermit Hall, per Jeremy's instructions.Perhaps someone at FINCEN can provide help with cases of this nature, in which we know the town where someone lives, but need access to an unlisted address and telephone number.SSN: [Screened by: NARA RD-F on October 24, 2016 according to the John F. The document is still "referred" (i.e., not open) so at this time I cannot put any of its contents in this e-mail, nor could we give him a copy of it even if he asked for one. If you need to call him to make sure it really is him, that's O.K.--tell him I will be calling him Wednesday morning to discuss some of the details of his 1977 written statement to the HSCA. If you are sure you have his CURRENT phone number and address, and don't need to confirm, then you don't have to call him--that's optional.Jim, I know Sydney is our number one FINCEN guy, but since he has hurt his back and is not here today, and I do not know if he will be here Monday, please take the lead on this Monday if Sydney isn't back. This is higher priority than your records project at the Archives!Good luck in getting an address and phone number for me to use on Wednesday. Ask for help--I'm sure they will be glad to assist.
