Participants included: Jack, Anna, Bill, and Henry. The principal points were:1. A FedEx package has been sent for Friday delivery that includes copies of documents that you may wish to examine.2. June 4 Board meeting. Plans are still in place for the June 4 meeting. There will be several items to discuss, so I particularly urge the Board to begin promptly at 9:15. The meeting with Chairman Burton is still scheduled for 11:00 a.m., although there is a mounting likelihood that it will be delayed or rescheduled. I hope to have more information by Monday. The open meeting is scheduled to begin at 1:30. Steve Tilley accepted the Board's invitation to attend. Nan Waffen plans to have a film crew present. Please return your agenda suggestions/recommendations to me as soon as possible, but no later than Tuesday. 3. Garrison materials. I am scheduled to go to New Orleans on Tuesday to pick up the materials. We have received excellent cooperation from the N.O. FBI, N.O airport security, US Air (which will permit the boxes to go into the cabin), and Washington-National Airport security.4. NARA. We still have no response from NARA on the fragment testing. During the course of our discussion, we agreed that I should call Tilley and then, if appropriate, send a letter to Carlin.5. CIA document. We had a cryptic discussion about the CIA document that was discussed at the last Board meeting. CIA has made a new proposal on handling it. We will discuss it at the next meeting.6. USSS Appeal. The Secret Service has made an ill-advised appeal. It is the same as was shown to you at the last Board meeting. Our reply is in the FedEx package. Although I am confident we should prevail on the merits, I am not confident about what the White House will do.7. PFIAB. I sent to Bill Leary my draft response to Rudman's letter to Ruff. He used the draft letter as talking points for a meeting with Frank Fountain at PFIAB. Leary called me after the discussion and said, "Jeremy, you need to understand what it is like for the PFIAB staff. It can be very difficult working for a Board of Presidential appointees who are very prickly about their prerogatives and jurisdiction." I acknowledged that I truly have no understanding at all of what it must be like for the PFIAB staff but I'm sure that it must be difficult.8. First-day copy of Zapruder film. Jamie Silverberg (Henry Zapruder's lawyer) has been very cordial and cooperative in allowing us access to their first-day copy of the Zapruder film. Rollie Zavada of Kodak will be coming down to examine the film in July.
