The only "surprise" or drawback is that I cannot write portion D, the "Final Disposition" of the Zapruder film--as I indicated in the draft, I believe only the General Counsel can write that.This was by far the longest, and most difficult section for me to write. Most of my writeups will be much, much shorter--in fact, as short as required to summarize the topic matter.However, in this case, I think any effort to cut up this Zapruder writeup of mine by taking out large sections just for the arbitrary sake of brevity would be a mistake. It is a complex subject (i.e., what we did and did not do), and I wrote it with Jeremy's edict of keeping our activities "trasnsparent" in mind. High public and researcher interest in this area is another reason to permit this portion to be more detailed than others. OTHER ASSIGNMENTS:I have not made the progress I would have liked on other areas of Chapter 6. If catching up "after hours" is the only way to do it, then my intention is to catch up by working one day each weekend in the near future. I do not want to work late on working days--I am not sleeping well at all and I think that would be counterproductive to my efficiency the remainder of the work week.As I said above, most of my other areas will be very short writeups. The one possible exception is LHO's IRS/SSA records, which will be the last thing I write up, since we are waiting for answers to requests for information, and Jeremy wants me to do a memo in that area also. I intend to do the "sanitized" memo first after we get the responses to our questions, THEN do the Chapter 6 writeup afterwards, unless instructed otherwise. (If I wrote the Chapter 6 portion of LHO IRS/SSA now, it would be grossly incomplete and I could not summarize our uncompleted work.)
