They did, however, create checklists or withdrawal sheets that corresponded to the log sheets we filled out.- They copied everything we had designated on the log sheets as either an AR or EHU, but I need to double check our records of the log sheets to make sure they are all accounted for.- They prepared RIFs for all the documents we had designated as ARs, but did not, contrary to instructions, prepare RIFs for the EHU records, most of which I believe should become part of the JFK collection. The EHU is more of an indicator of the relative importance. Steve Tilley designated a lot of the records he reviewed as EHU's (the Bromley Smith and McGeorge Bundy Papers) even memos that mentioned the Warren Commission, but these should really be regarded as AR's. I think this was just a matter of interpretation of the meaning of EHU (enhance historical understanding) vs. AR (an obvious assassination record). He said himself that the Library should have prepared RIFs for all the documents we identified while we were down there. The RIFS were not entirely complete; the title line was left blank. - There are approximately 344 documents. Of these, 231 have RIFs, the remaining 113 (EHUs) do not. The majority of the referrals will be to State, White House/NSC, CIA, and DOD (specifically OSD), followed by FBI, Air Force, USIA, possibly some Secret Service. I can provide the specific numbers but there are cases where there is some overlap. There were some travel itineraries and passenger lists which were designated as White House records, but I think these may be Secret Service material. Steve believes that NSC will probably leave it up to State to review the pertinent documents. - Steve is going to have the set wrapped so we can have someone bring it down to us. - I need to speak to Tina once again about the RIF situation and will request a copy of the diskette.
