She raised two additional points about the whole staff having computer viewing access to parts of the All Names Database and parts of the Public Contacts Database. I think that a new view for each of these two databases would take care of her concerns. Here are my ideas: All Names Database -- Social security numbers, date of birth, and place of birth are the problems here. How about giving the whole staff a view that includes the name, the connection to the assassination, and the source of the information? We can keep the SSN and the date and place of birth as long as it is only distributed to others only on a need to know basis.Public Contacts Database -- The home addresses, phone, fax, etc... of Presidential Commission and Congressional Committee staffers are the problem. How about a view giving the whole staff access to all the information except home addresses, phone numbers, and fax numbers? We can keep the personal information, but we need to restrict access to others in the office on a need to know basis.
