I had six HSCA records processed at this meeting, descriptions of which follow:180-10103-10488 and 180-10094-10334. These two were referred to Customs (previously unreleased), which requested the redaction of agents' names. Customs provided no evidence on behalf of the redactions and the Board opened the records in full. Record -10488 is an HSCA Outside Contact Report w/Customs, re: locating individuals who were Customs employees in Dallas, circa 1963. Record -10334 is a Customs document concerning an organized crime meeting in Miami; said document was in the Metro-Dade Police files Gaeton Fonzi secured for the HSCA.180-10077-10050. This record consists of multiple-year tax returns for Eileen (Jack Ruby's sister) and Harold Kaminsky, previously unreleased. SSNs (104 of them) have been redacted. Eileen is deceased, and Harold was contacted and gave permission for the documents to be released as long as SSNs were redacted.180-1077-10307 and 180-10080-10216. Both of these were referred, previously unreleased documents which contained a SSN, so the Board released them for the first time while redacting the SSNs. Record -10307 is a U.S. Marshall's Service file on John Dane. Record -10216 is simply a records request letter from Bob Blakey to the DoJ.180-10110-10091. This is probably the most interesting of the HSCA releases for this meeting. This record is a previously referred and hence unreleased DOD record from the HSCA Security Classified Files record series. DOD asked for the redaction of various home addresses and phone numbers (circa 1978) from the documents, but provided no evidence so the Board opened the record in full. The record consists of: 1) a cover sheet from Judith Miller (Assistant to The Special Assistant to the Secretary of Defense) to Jacqueline Hess of HSCA and the following attached documents, 2) "Fact Sheet on Protective Services", 3) "Fact Sheet on the 112th Intelligence Corps", 4) "Fact Sheet, Subject: Destruction of Oswald's IRR Dossier", 5) "Fact Sheet on Sales to Haiti", 6) "Fact Sheet on Personnel Involved in Oswald's Discharge".
