Although we do not normally handle requests like this (lack of personnel/resources for these requests), we checked into it with the staff at NARA II.The document (179-40005-10008) is OPEN IN FULL. According to Martha Murphy at NARA II, it is an FBI document that was reviewed by the Bureau in January of 1995, and opened in full. The document is currently in the Warren Commission referred boxes at NARA II, however no existing electronic database reflects this status.One of our senior analysts has offered to obtain a copy for you while he is at NARA on Monday.
