It is, of course, much more complete than the version published by the HSCA in 1979 (X HSC 151-165). However, I was recently comparing the two versions, and discovered to my surprise that the version published in 1979 contains, in nine different places, words or sentences that are redacted in the version that was released in 1994! In total, there are 13 complete sentences, and parts of an additional three sentences, un-redacted as printed in 1979 but redacted in 1994.
