Date:01/15/97Subject:White House ComplianceSummary of the Call:Yesterday, I called Mr. Tilley to review with him whether there are any records within the control of the White House that may relate to the assassination of President Kennedy and that would not necessarily be found at the LBJ or JFK Libraries. Mr. Tilley confirmed that Presidential papers are with the libraries. However, NSC records would be located at NARA and, indeed, those records from the LKennedy and Johnson administrations have been reviewed for assassination-related records. However, Mr. Tilley was not certain whether the NSC's Intelligence Directorate records were reviewed. Mr. Tilley indicated that the relevant records from the Directorate that should be reviewed would be from the "303 Committe," which was the covert action committee under the NSC. Another potential category of records not with the Libraries are records of the Foreign Intelligence Advisory Board and the President's Intelligence Advisory Board. Mr. Tilley was not certain where such records would be kept. On the issue of White House records generally, Mr. Tilley suggested we talk to Terry Good of the White House Records Management Office. Mr. Good has worked for the White House since the Johnson Administration, according to Mr. Tilley. I suggest we interview Mr Good to more specifically ascertain whether there are any major categories of records currently within the custody or control of the White House that may contain assassination-related materials. Let me know how you want to proceed. Don't forget to compose individual Action Item documents for any action items that resulted from the call!
