When the Review Board designates the material an "assassination record," we can thank them for drawing it to our attention. Some of it seems to be White House Detail material to which my list of boxes to search directed them. The rest of the material appears to be the first information from a field office we have seen. This may be the result of the initial compliance letter Ron sent in November. With regard to the transcripts, we should examine everything the Service is willing to show us.I showed Ron and David the final paragraph regarding the Secret Service compliance statement on Friday afternoon. I spoke with John Machado briefly as he was walking out, and he said that Vezeris's mother had been sick. Vezeris has been in and out of the office over the past couple of weeks.
