(Dave Montague can provide the NARA I.D. # if you need it.)I do not know if there is an audiotape of the first (sworn testimony) Finck session--but I know the transcript of that Finck and Ebersole testimony, produced by a court reporter, was released in 1993. (They testified on the same day.)The audiotape of the Knudsen testimony at his deposition is a big disappointment--it consists of a court reporter speaking into a "cup," apparently repeating into her cup every word spoken at his deposition. It is barely intelligible, and you never hear Knudsen's voice, even once. However, we screened this tape and did not notice any differences between what the reporter said into the cup, and the transcript. These two tapes are MIS-LABELED by NARA as "233JFK.014619 RL 3 of 3 Side A, Side #1 and Side #2, Witnesses M. Shore and A. Gruber," whereas in reality these two tapes are really Knudsen's court reporter. There ARE 4 other tapes also labeled as "Shore and Gruber," namely 1 of 3 and 2 of 3, which really ARE Shore and Gruber.
