Jeff--In answer to your questions:1. The Salvat and Borja documents are still being reviewed by the CIA. Although I expect the agency will be finished soon, I don't know when. The document numbers published in the HSCA volumes are incorrect. The correct number for the Borja interview is HSCA 005765 (RIF 180-10077-10422). The interview was conducted on February 13, 1978, and memorialized on February 21. The correct number for the Salvat Roque interview is HSCA 005259 (RIF 180-10080-10262). The date of the interview is not recorded, but it was memorialized on February 7, 1978.2. The Board has not voted on these records because we have not yet received the CIA requests for postponements.3. I assume that you are asking about the CIA's sequestered records and not the HSCA records. I don't know the exact number. There are, however, thousands of records awaiting review.4. To the extent that we identify missing records, we attempt to pursue them. Even though we have spent many person-hours examining Cuban exile records in the CIA's sequestered collection, it is not necessarily clear which records are missing and which may be misfiled. We will be pursuing, for example, all monthly operational reports for DRE for the relevant time period. It is not yet clear whether they already are in the sequestered collection or not.5. Not yet. We want to have a clearer notion before we make such a request.6. It would be helpful to me if you could clarify some of the documentary issues that we have discussed over the past year or so. I will treat your answers strictly as background material, not for publication.1) What is the status of the HSCA interviews of Juan Manual Salvat and Sidro Borja?2) -Has the board made a recommendation about release of these two documents?3) How many documents from the sequestered collection remain to be reviewed?4) What is the board's approach for obtaining documents which, logically, should have been in the sequestered collection but apparently are not? I am referring specifically to the monthly reports on AMSPELL/Directorio Revolucionario Estudiantil from Nov. 1962 to April 1964. The reports on August 1963 (when the DRE had contact with Oswald) and Nov. 1963 (when the DRE went public with information of Oswald) are, of course, of greatest interest.5) Are these documents included in the "outstanding requests to the CIA" referred to in the annual report?6) If so, has the CIA responded in any fashion about the existence and/or location of these documents? Thanks for your consideration. jeff
