 Date: 04/07/97Subject: UpdateSummary of the Call: On Monday, April 7, 1997, Dr. David Vanek called me in
 response to numerous efforts in the last two weeks by both sides to contact one another. Dr. Vanek has been
 contacted before by ARRB and in fact has submitted an affidavit to us regarding allegations raised by Col. Dan
 Marvin. It is not necessary to detail Marvin's allegations in this report; it is enough to say that Vanek's affidavit
 effectively reputed or denied Marvin's story. Dr. Vanek had tried to reach Tim Wray in the week preceding
 his departure; the two played phone tag, and upon Tim's departure I assumed the responsibility of returning
 Vanek's call, which I have been trying to do for the last week. Vanek wished to inform us that Marvin had
 tracked him down through use of a private investigator and had been mailing him materials. I reiterated to Dr.
 Vanek that the only action taken by ARRB which might have contributed to this matter was having sent Marvin
 a copy of Vanek's affidavit. Vanek did not sound angered or distressed; rather, he was very calm and even-
 spoken about the whole deal. He told me that he has not responded to Marvin and was prepared to just let
 the entire matter drop unless I counseled otherwise. I told Vanek that his response was up to him, but that
 we certainly saw no harm in his ignoring Marvin. I asked if there had been multiple contacts-- that is, was
 Marvin harassing him; Vanek responded that there has only been one letter, and that he hasn't been
 contacted beyond that. I suggested that if he ever felt that further contact with us was necessary, he should
 feel free to call us, but I felt that the matter was now closed. He agreed, and stated that all he wanted to do
 was to make us aware of Marvin's contact. In closing, I would like to state again for the record that our contact
 and involvement with Vanek is now closed, and that no further action is called for. ENDDon't forget to
 compose individual Action Item documents for any action items that resulted from the call!
