Had they been done properly, we would have been able to affix Final Determination Forms to them and get them to NARA. However, as I reviewed and double-checked them, I found that between substitute language problems, mistakes in redactions (either withholding things the Board had released or relasing things the Board agreed to protect), and classified material in the RIF's, about 50 of the 85 documents were improperly prepared and would have to be redone. I called our NSA p.o.c., and he and I banged out the problems over the course of several phone calls. After we settled everything, he agreed to get me "new" versions of everything and that we would go from there. As of this writing, we have yet to receive these new versions from him. Even before having gotten this e-mail yesterday, I had already placed a call to our guy to try and goose him into moving things along. As of this morning, he has yet to return my call. So, that's where things stand. Please pardon me if this note has a curt tone; people have been on me for a couple of weeks about this and it is getting a little frustrating to have to keep saying that it's out of my hands and that I have to this point done all I can do. When our p.o.c. calls me back (if he hasn't called by midday today I will call again) I will emphasize to him that I need to get the new versions asap.
