Based on my June 27, 1997, conversation with Kevin Jessar of the NARA GC's office regarding the Snyder deed, it seems that the Sawyer Deed of Gift is going to need to be changed., If you recall, as a condition of Sawyer's donation, he wanted to keep a copy of his materials, just as David Snyder did. When we sent Snyder's deed to the Archives, Kevin Jessar said that paragraph 8 of the Snyder deed varied slightly from NARA's standard language -- the standard language is more protective of the Donor's rights than the language we used. We had replaced the part that says that the Donor has the right to obtain reproductions from time to time at the discretion of the Archivist with language that said that the Donor would receive a single copy at the time of the donation, period. Jessar said that it would be fine to provide the Donor with a copy at the time of donation, but the Donor should still retain his right to obtain reproductions from time to time thereafter. I changed the language in the draft of Snyder's gift and I will now change the language in Sawyer's draft to read: (paragraph 8):"The Donor may, upon request and from time to time, obtain reproductions of any or all of the Donated Materials. The Archivist, or his or her designee, shall determine at the time of each request whether reproductions are to be provided free of charge or, in the alternative, for a fee set in accordance with the provisions of chapter 21 of title 44, United States Code.
