ISSUE 1: Do you have plans to come to DC next week (Sept. 29-Oct. 3)? Answer: Yes. I expect that Jack will verbally tell me tonight that all the components of the plan/offer for me are in place. Although I have not made the travel arrangements yet, I plan on doing what will, I think, become the routine, which is Tuesday, Wednesday and Thursday in DC (Tuesday, Sept. 30 through Thursday, October 2 for next week).
ISSUE 2: I currently am scheduled to be away between Thursday, October 9 and Sunday October 19 on commitments I made before recent developments. The schedule for me is as follows:
1. Oct. 9-11 Ohio Answer: For this week of Monday, October 6, I thought I could shift the Tuesday-Thursday plan to Wednesday, October 8 through Friday, October 10 to provide "coverage" for the two days (Thursday, October 9 and Friday, October 10) that you will not be in the office for this week.
2. Oct. 11-15 Budapest (returning mid-afternoon; I hope to come to office)
3. Oct. 16-19 Atlanta. Answer: For this week of Monday, October 13 - Friday, October 17, I suggest, and think I can do it, that I be in DC for Tuesday, October 14 - Friday, October 17; thus, adding a fourth day in DC and leaving only one day (Monday, October 13) of the relevant seven working days when one of us is not in the office.
