I had cordial conversations with both men, and scheduled deposition dates with both of them for the following dates:Ed Reed: Tuesday, October 21stJerrol Custer: Tuesday, October 28thScheduling dates compatible with their work schedules and travel desires, and also compatible with Steve Tilley's desires and our own scheduling constraints was not easy, but ultimately we settled on dates which are acceptable to them, providing their travel desires are met.3. Tracy, I need to get with you soonest in order to coordinate travel arrangements for each individual. This one is a bit complex, in that both men want a travel advance (which will require us having to send them a travel advance authorization form in the mail ASAP). I will try to sit down with you as soon as you are back to get things rolling; their are other complexities that I will explain in person. 4. I have passed both dates to Steve Tilley, and have told him that each deposition will start in the morning, which is his strong preference. (The Oct 21st date is a date which Tilley said was O.K.; the Oct 28th date will require him to resked his dental appointment, but it was the only option open to me and I have explained this to Steve in a voice mail.)5. These are taking place prior to the Rochester event, which may turn out to be quite important.6. I am extremely pleased about this turn of events, and am gratified that this Board decision will result in important additions to the historical record.
