Review Board's representative in the call: Ron Haron Department of Defense -- Washington Headquarters Services's representative in the call: Daniel Cragg Description of the Call Date: 01/06/98 Subject: Compliance Statement -- Office of the Secretary of Defense Summary of the Call: I called Dan Cragg to ascertain the status of of the Final Declaration of Compliance that was to be, but has not been, submitted by December 19. Mr. Cragg relayed to me informally that there are a number of internal personnel issues that are delaying the submission of OSD's Final Compliance Statement. I said that we would like to have the Final Statement by the end of January, if possible, and I would prepare a letter confirming that. In addition, OSD had promised to last summer to contact John Kester regarding the whereabouts of his files. John Kester was the principal contact with the HSCA on behalf of Department of Defense entities. I think we should proceed to contact him ourselves (I recommend that Doug and I call him). Of particular importance is a letter that Kester wrote to the HSCA stating that a review of certain intelligence holdings disclosed no Cuban complicity in the assassination of President Kennedy. We still have not identified the underlying records that were the basis for this conclusion. In addition, DOD has certain materials relating to a polygraph examination of Jack Ruby; I have asked that those materials be messengered to us so that we can ascertain whether these materials have ever been previously released. Don't forget to compose individual Action Item documents for any action items that resulted from the call!
