 Subject: Doug Horne Called Will Kammer  
 Summary of the Call: I called Will Kammer at the Joint Staff to set up an appointment to review the 5 Top Secret Joint Staff history volumes (3 on Vietnam, one called "The Global Challenge," and one titled "The Succession of Crises"). My appointment is for this Friday morning at 10:00. I explained to him (and to Paul Jacobsmeyer, his new colleague) that following my review, Jeremy Gunn would also come over and review my recommendations vis-a-vis what the Review Board should consider "assassination-related." I told him that following his own evaluation, Jeremy would make recommendations to the Board, the Board would make a determination as to which chapters, or portions of chapters, were "assassination records," and the ARRB would then notify the Joint Staff in writing as to which select portions of these documents should be reviewed and submitted to the ARRB in accordance with the JFK Act. They understand our methodology, and concur.
