The FBI files appear to contain none of the names he lists in his letter to the ARRB; although, I will do a more thorough check at the FBI this afternoon. We will designate some of the information related to the riots at the University of Mississippi that relates to General Walker, but not for the same reasons he suggests as the FBI files do not appear to contain or substantiate his claims of assassination related persons being at the University of Mississippi riots. Again, I will look into this further just to be sure and will e-mail you with those results.
