There is also cause to wonder what happened to the Fenton Report, long known to researchers but never seen--why isn't it among the HSCA documents released by the ARRB? I'll copy this to ARRB chair John Tunheim, to see if he has an answer to it. As for Gordon Novel, he has proven a bit slippery over the years--he was protected from Garrison by Ohio Gov.
