He wanted to talk about two things:-Are our medical depositions and interviews open documents? (He recalled Eileen telling him they were, and said he had called Steve Tilley and found out they were not open yet.) [Eileen confirmed to me later that she had given him a list of names by fax, and had told him that the fact they had been conducted was open information, but NOT that the documents were open, so in essence, he misunderstood Eileen.] I told him we expected them to become open documents prior to our shutdown on September 30, 1998, but I could not tell him exactly when.-He wanted to discuss Kennedy's brain, and alluded to a purely personal opinion Jack Tunheim expressed last week--namely, that it may have been buried at the reinterrment in 1967. I told him two things:-First, I told him that I could understand why someone might think that, based on the small unexplained box in the photographs held by the JFK Library. I neither agreed with nor disagreed with Chairman Tunheim.-Second, I read to him, chapter and verse, from HSCA Volume 7, specifically pages 31, 32 and 33, in which the HSCA opined that it was not buried during the reinterrment, and that Robert F. Kennedy probably disposed of the brain. I emphasized to him that I was not disagreeing or agreeing with Chairman Tunheim, and that he should form his own opinion after studying the evidence. He asked why we interviewed so many pathologists and embalmers, and I said "no comment." He persisted, so I reminded him that while we were NOT reinvestigating the case, and our primary job was to locate records and place them in the Archives without comment, that from time to time, in order to attempt to clarify the record, we did a deposition or an interview of a medical witness. I asked him to be patient for the release of these materials, and he said it looked like he would have to sit on this story for 2 or 3 months. I also asked him not to use my name. END Record
