the FBI team update on our activities since February 20, 1998."The FBI team has negotiated 20,128 pages of  
records from the HSCA subject files with the FBI. The HSCA subject files that have been through the  
negotiation stage include: James Allegretti, American Gambling Activities in Cuba, Eusebio Asque, Dr. Jose  
Ignatio Rasco Bermuda, Eugene Hall Brading, Joseph Civello, Lucien Conein, FPCC, Macho Gener, Martin  
Greendlinger, Peter Paul Gregory, Loren Eugene Hall, Marcos Diaz Lanz, Pedro Diaz Lanz, Paulino Sierra  
Martinez, Robert Ray McKeown, Albert Meadows, Sylvia Odio, Sam Paxton, Carlos Rodriguez Quesada, Jack  
Ruby (Chicago ELSUR), Richard Snyder, John Benton Turns, and Anthony Zoppi.Although the FBI page count is  
over 20,000 pages this month, the pace of the FBI's review is slowing. We have again communicated to the  
FBI that the pace of their review must accelerate if the Review Board is to complete its work by the end of the  
fiscal year. The FBI has advised us that it does not anticipate that it will be able to accelerate the pace of its  
review to the levels necessary for the Board to finish in a timely manner. We are engaged in an ongoing  
dialogue with the FBI to try to resolve this emerging problem as soon as possible and we intend to update  
Congress on any new developments."I am copying Kevin on this e-mail so that he can send you the final  
number of green documents and consent releases from March.If you have any questions or if you need
