 Thanks, Eileen. I spoke with Jeremy this morning about the Waffen issue. He may have already
 spoken with you, but I told him that I believe that we need to cooperate, but that the level of cooperation should be commensurate
 with our many responsibilities to wrap up our effort. I plan to raise the issue generally with the Board (our
 minimalist cooperation) and Jeremy suggested that I meet with Waffen, perhaps for breakfast on Wednesday.
 (Another thought, maybe it would be good for you to join us for breakfast). My thought is that I can do
 an interview and perhaps one additional Board member (Bill, maybe?) and we can let them film some work
 going on in the office. Do you think that this is a reasonable response? I don't think that Jeremy wants to be
 interviewed, unless the entire Board is interviewed and he needs to address some of the additional issues that
 might be raised under such a scenario. Kermit and Anna have raised legitimate concerns, I think, but we are
