Subject: Body: recstat: DeliveryPriority:	Robert Groden: A former trainee and optics technician for Moses Weitzman (circa late 1960s) at EFX, Unlimited (a New York film lab), Mr. Groden obtained access (via Mr. Weitzman, circa 1968 or 1969) to left- over 35 mm enlargements (workprints) of the Zapruder film, and publicly aired the film for the first time on television in 1975. He aggressively lobbied in favor of a Congressional Investigation of the Kennedy assassination, and his repeated showings of the Zapruder film, and other motion pictures of the assassination (such as the Nix and Muchmore film), led to the successful creation of the HSCA; as a result, the HSCA allowed him to have access to many assassination-related photographic materials as an unpaid photographic consultant.
