 Dear Tracy: With regard to the audio donation: Next Monday, Aug. 31, Pat Valentino will be shipping you, Fed Ex, the first of two shipments of CD's. This first shipment---which will consist of approximately 25 CD's--- will arrive on Tuesday, 9/1, via Fed Ex. It will contain approximately 3/4 of the promised donation---i.e., the material on the list when I testified. Pat Valentino will include a draft copy of the invoice in that shipment. We plan to have the remaining materials of the promised donation---which will be mostly on CD's (but may include a few cassettes)---will be delivered to the ARRB BY Wednesday, September 9. A final invoice will be in that box. Please note: with the possible exception of a few cassettes in the second shipment, the material being donated will \*not\* be on DAT (digital audiotape) but rather will be on the more advanced and even more enduring format of CD's. This switch from DAT to CD format is one reason things took a little longer than expected. As I mentioned, in the course of going through my very extensive audiocollection, I have marked certain additional interviews that I think are of historical importance, but which were not on the "original" donation list when I testified in Los Angeles before the ARRB. One of these, for example, is a more than 1 hour interview with JFK assistant press secretary, Malcolm Kilduff, who was riding in the press car and played a major role in the events of the day, but was never interviewed by the FBI or the Warren Commission. Another is Senator Ralph Yarborough, also riding in the motorcade, who gave a relatively brief statement to the Warren Commission, but who I interviewed at length just before the publication of Best Evidence. These are just two examples. These are just two examples ---of about two dozen---of what I will call "supplementary material". These are items which I believe are relevant, but were not part of the promised donation list. Pat Valentino has offered to put these, too, on CD Rom, and for free, but they will not be ready by September 9. I plan to speak with Steve Tilley about sending these directly to him, after the ARRB shutdown. To recap: we plan to have the promised donation sent in two parts: (1) the shipment of a box of CD's, scheduled for arrival at the ARRB on Tuesday, 9/1; along with a draft copy of the invoice; and (2) a Record
