LuAnn -- here are the relevant excerpts from my monthly reports:

October 24, 1997 report:

Since September 11, 1997, the FBI team has negotiated **31,423** pages of records from the HSCA subject files with the FBI. The HSCA subject files that have been through the negotiation stage include Bill Anglin, Lev Aronson, Arthur Balletti, Morris Block, George Bouhe, V.J. Brian, Comer Clark, Janet (Jada) Conforto, Fred Lee Crisman, Cuba Libre, Harry Dean, Ejercito Cubana Anticommunist, Lawrence John Howard, Harold Isaacs, Gilberto P. Lopez, Maurice Medlevine, Isadore Miller, Frank Nelson, Edward Grady Partin, Earlene Roberts, John Roselli, Dalton Smith, and John Eli Stone. Several files are nearly through the negotiation stage, including Orlando Bosch-Avila (the never-ending file), Angelo Bruno, Dino Vincent Cellini, Frank Chavez, E. Howard Hunt, Gabriel Mannarino, Sam Mannarino, and the MDC.

Since September 11, the Review Board has had two meetings. In September, we reported 956 FBI records that are consent releases. In addition, the Board voted to postpone in part 313 FBI records. In October, 1151 FBI records are consent releases and the Board voted to postpone in part 440 FBI records.

November 26, 1997 report:

Since October 24, 1997, the FBI team has negotiated **37,777** pages of records from the HSCA subject files with the FBI. Since October 24, when I last reported to you, the Review Board had their November meeting on 11/17/97. At that meeting, we reported 2319 documents that are FBI consent releases and the Board voted to postpone in part 676 FBI records.

December 29, 1997 report:

Since November 26, 1997, the FBI team has negotiated **14,522** pages of records from the HSCA subject files with the FBI. The HSCA subject files that have been through the negotiation stage include Barney Baker, Joe Bond, Crime Conditions, Alexandra Gibson, James Gilmore, Augustin Guitart, Gerald Lynn Hill, John Birch Society, Billy Nolan Lovelady, James Herbert Martin, William M. McKenzie, John McVickar, Thomas R. Peasner, Arnesto Rodriguez Jr. and Sr., J. Herbert Sawyer, Clay Shaw, and Joe H. Tonahill.

The FBI team has reviewed, but not negotiated another **37** files. Our staff members are waiting for the FBI staff members to negotiate these files.

Since November 26, the Review Board had their December meeting. From that meeting, the Board voted on 822 FBI records and we reported 2607 FBI consent release records.
