Re: June 1 Meeting

This memorandum sets forth what Terry O'Connor, you, and I discussed in our meeting yesterday regarding David Marwell's May 23, 1995 letter to Terry:

1) The Bureau's proposal to respond on June 5 to the May 23 letter is perfectly satisfactory.

2) The FBI agrees to release in full the following documents:

As you know, many of the documents listed above are duplicates. The May 23, 1995 letter listed the duplicates of these documents that the ARRB staff has identified to date. You kindly agreed to search the FBI inventories for any other duplicates identifiable by that means, and to release those duplicates as well. If you do locate further duplicates, please let me know.

3) At this time, the FBI declines to release the postponed material in HQ 44-24016-1581 and its duplicate DL 44-1639-5245. As to HQ 105-82555-54, the FBI agrees to release the references to DL-16-S and DL-20-S and the name and address of Andrea McCormick, but at this time does not agree to release the other information postponed in this serial. As to HQ 44-24016-473 and its duplicate DL 44-1639-103, the FBI agrees to release the references to CG 5609-S, former CG 5373-S, former CG 5042-S, and former CG 5912-S, but at this time does not agree to release the other information postponed in these serials. Of course, the Review Board eventually will determine whether to sustain or reject the remaining postponements in these documents. The ARRB staff will give the FBI advance notice of when it will present these postponements to the Review Board for such determination. We do not intend to do so at next week's Review Board meeting.

4) As we discussed, the Bureau's June 5 response to the May 23, 1995 letter should confirm that this memorandum accurately reflects our understanding from yesterday's meeting as

to the disposition of the documents discussed above.

5) At the end of yesterday's meeting, I promised to let you know today whether the ARRB staff would present the documents listed in paragraph 2 above to the Review Board at next week's meeting in the event that the FBI had not yet physically transferred the unredacted documents to the JFK Collection. In the light of the FBI's agreement to release these documents without formal action by the Review Board, such a step seems unnecessary.
