RE: ARRB Review of FBI Documents, July 17-18, 1995

Dear Terry:

The ARRB staff has identified a number of FBI documents that we intend to present to the Review Board for review of postponements (and "NAR" determinations) at the Review Board meeting on July 17-18, 1995. These documents are identified in the enclosed forms. There also are several additional documents that we intend to present at the July 17-18 meeting, but for which we do not have RIF entries in our database. These are:

We are identifying these documents to you now so that you may submit any additional evidence or arguments to the Review Board staff in advance of this meeting. So that we may adequately prepare our presentation to the Review Board with the benefit of any submission you may wish to make, we request that you provide us with any document-specific evidence or arguments by July 10, 1995.<sup>1</sup> Although the enclosed forms suggest that you submit evidence or arguments in support of asserted postponements (and "NAR" determinations) in writing, we will be happy to discuss with you other means of presentation that may be more convenient or practicable (e.g., formal presentations to, or informal meetings with, ARRB staff members).

<sup>1</sup> In the event that we identify additional FBI documents that we wish to present to the Review Board on July 17-18, we will give you sufficient time to make similar submissions with regard to those documents as well.

Among the documents identified in the enclosed forms are documents in which the CIA has equities. These are:

We are also giving the CIA advance notice of the intended review of these documents on July 17-18, so that the CIA also may submit whatever document-specific evidence or arguments it may wish in support of postponements in which it has interest. It is our understanding, based upon our review of the identified documents, that these are the only identified documents in which a third agency has equities. If there are any other such documents among those identified in the enclosed forms, please so advise us.

We have attempted to identify separately the duplicates of each of the identified documents, wherever they may occur in the FBI's core and related files. However, if in some case we have failed to do so, please understand that the Review Board's decision with regard to one document will apply to claimed postponements (or "NAR" determinations) regarding the same material in duplicate documents.

Finally, with respect to some of the identified documents, we believe that the FBI could, consistent with its current guidelines, consent to releasing material that is now postponed. We hope to discuss these documents with members of the JFK Task Force shortly. In the same vein, if the FBI decides to release any of the presently withheld material in the identified documents, please let us know promptly.

As always, thank you for your continuing cooperation.
