Does CE 842 *currently* contain the actual bullet fragments from the Governor's wrist, or just photographs? If you happen to know the answers to these sorts of questions yourself -- and if it easier for you to simply communicate the information to me, as opposed to pulling the exhibits -- then that is fine with me.
