SUBJECT: Search of Files of Secretary of the Treasury C. Douglas Dillon and Assistant Treasury Secretary Robert A. Wallace

On October 2 and 3, 1997, I searched the finding aids at the National Archives and Records Administration ("NARA") for any files of Secretary of the Treasury C. Douglas Dillon and Assistant Secretary of the Treasury Robert A. Wallace. I found the following entries in NARA's Master Location Register:

- Index of Office Files of Secretary Douglas Dillon Accumulated by the Executive Secretariat of the Office of the Secretary of the Treasury 1961 - 65.

My review of some of these files disclose that they contain a large number of index cards that are not organized particularly well; it would be more beneficial to review the documents themselves. The index cards seem to correlate with documents at entry 198D described below.

- Office Files of Secretaries, Under Secretaries, and Assistant Secretaries 1932 - 1965 (Executive Secretariat Files of Douglas Dillon 1961 - 1965).

Since these documents are classified, I was unable to review the files. However, the documents may have been reviewed in September 1995 by Dennis Quinn. Mr. Quinn states in his September 18, 1995 memo that he reviewed the Office Files of Douglas Dillon, but I am not sure if he is referring to the documents under entry 198D.

I also looked very briefly at the following records of Assistant Secretary Wallace:

- Miscellaneous Records of the Secretary and Assistant Secretaries, Office Files of Assistant Secretary Robert A. Wallace 1963 - 67.

Again, I was able to do only an extremely rough survey of these documents. With a NARA staff member, I went into the stacks and looked at the outer labels on the Wallace boxes. Out of 11 boxes, only one box was labeled Secret Service. I opened the Secret Service box; the box contained two files pertaining to the Secret Service: (1) a budget file and (2) a miscellaneous file. I reviewed the miscellaneous file and found nothing of relevance.

I was unable to look at the following records, which we had discussed reviewing, because of time constraints:

- The Records of the Office of the Assistant Secretary for Enforcement & Operation; Records of the Special Assistant Relating to Organized Crime, 1956 - 1969.
