Dear Ms. Thrapp:

As a follow-up to our telephone conversation of December 2, 1994, I would like to bring several issues to your attention.

First, I have enclosed copies of six newspaper articles from daily newspapers around the country which relate directly to the Board and which I gathered from other sources, but which have not been received through the Luce Press Clipping service. Per your suggestion, I waited to see if they would appear in packages sent subsequent to our conversation, but many of them are now more than a month old and they have not appeared. I thought you should be aware of these clippings. Please advise me of any thoughts you may have on this matter.

Second, I have enclosed (92) different television notices regarding the airing of the movie "JFK" in November. I am asking if our account could be credited for the total value of these clips. It seems to strain common sense to think that all of these notices would be of any value to our Board. I would appreciate it if you could inquire into whether or not anything could be done about the charges for these clips being removed.

Third, in the confirmation notice regarding our 12/2/94 telephone conversation, dated December 5, 1994, it states that I should allow ten working days for the changes in our service to be implemented. I look forward to seeing the changes because even the most recent package, dated 12/15/94, contained many duplicate clips and clips which come outside of the new parameters which we set on December 2, 1994. I look forward to seeing the new, stricter guidelines implemented and reflected in the clips we receive in the future.
