On 1/30/64 [redacted] Office of the Special  
Assistant [redacted] the Embassy, Bern, furnished infor-  
mation which has been made the subject of a letterhead  
memorandum, 6 copies of which are enclosed. ~~(S)~~

T-1 in the enclosed memorandum is OSA and the  
memorandum is classified confidential since the original  
information was so classified. ~~(S)~~ (u)

In addition, [redacted] mentioned that when a check had  
been made by his agency with the Bureau concerning subjects  
the following information had been obtained: ~~(S)~~ (u)

EGAN had been the subject in an ITSP case involv-  
ing fraudulent checks and bonds. RYAN was on probation on  
an income tax violation, had been a subject in an AR case,  
and was a potential witness under protection of the U. S.  
Marshal, in Denver, Colorado. ~~(S)~~ (u)

Both EGAN and RYAN had been allowed to go to  
Switzerland on a business venture. It was considered that  
EGAN might possibly develop some information concerning  
bank accounts of U. S. gangsters in Switzerland. ~~(S-D)~~ (u)

The Bureau is requested to furnish any pertinent  
material concerning these individuals for dissemination to  
interested U. S. and Swiss agencies. u
