Enclosed are five copies of a letterhead memorandum titled "CLIP" dated July 23, 1960. It is suggested that the Bureau disseminate this on a limited basis, especially to CIA.

This letterhead memo is classified "Secret" as it relates to a project which has been so classified by CIA in previous communications.

The tenor of the information contained in the letterhead memo very definitely reflects that there is considerable dissension among Cuban leaders of the "CLIP" operation. Due to the seriousness of the information furnished by CAJIGAS, FERNANDEZ, CUESTA, ROS, and Mrs. VALENTINER, the substance of this information was furnished promptly, as it was received, to BERNARD REICHHARDT, CIA representative in Miami. He confirmed that it is true that there is such dissension among these Cubans. He expressed concern and appreciation for having been furnished the information.

With regard to Mrs. VALENTINER, she also furnished two automobile license numbers which she had observed used by the Cubans who participated in the meeting in Apartment #209 on July 19, 1960. She also stated that she had disclosed the nature of this meeting to several of her friends, Mrs. WILLIAM ROBINSON, Mr. LAWRENCE BREWER, head of Esso Standard Oil Company, Havana, and Mrs. CARL MORRIS, wife of a Standard Oil executive in Havana, all of whom now reside in Miami and who are very anti-Castro. Upon request of Mr. REICHHARDT, Mrs. VALENTINER was requested to refrain from discussing this incident with any other persons and to make every effort to prevent her three friends from discussing the matter with anyone any further.
