The subject was [redacted] in the communist-dominated Greek Maritime Organization, OENO. His past activities have been the subject of correspondence between us and CIA. During the past year [redacted]

[redacted] subject's desire to remove himself from the OENO atmosphere. (S)

On September 13, 1960, Mrs. Jane Roman, CIA, advised that the subject is currently a crew member of the SS Radnor, which is scheduled to dock at New Orleans within the next two weeks. [redacted] is (S)

now endeavoring to work out an arrangement whereby he can travel to Cuba [redacted] (S) In order to arrange for such travel, it will be necessary for Moutos to jump ship at New Orleans. This will be done [redacted] (S)

[redacted] then hold conferences with Moutos and subject will thereupon proceed to Havana [redacted] (S)

Prior to leaving for Havana, Moutos will endeavor to have contact with his wife, Angela Boyer, who is well known to us and who has a communist background. His marriage to Boyer [was actually promoted in order to improve his position in OENO] (S) He has been separated from his wife for a lengthy period although she has indicated that she desires to live with him again. [redacted] (S)

[redacted] a resumption of relations between the two will help (S) Moutos [redacted] in communist circles in Cuba. (S)
