Reference is made to the Foreign Service Despatch
Number 284 dated March 22, 1961, from the American Consulate,
Kingston, Jamaica, British West Indies, to the Department of
State, Washington, D. C., entitled "List From CID." The
subject is mentioned in paragraph two of this Despatch. (S) (U)

A confidential source who has furnished reliable
information in the past advised our Miami, Florida, Office that
Ramon Iglesias Vasallo received mail at 2536 Southwest Eleventh
Street, Miami, in the name of Ramon Mendez. Our source advised
that Iglesias was a member of the Frente Revolucionario Democratico.

On May 3, 1961, Mr. [redacted] who is employed
by your Agency in the Miami area, advised our Miami Office that
your Agency has an operational interest in Ramon Iglesias Vasallo.
Accordingly, no further inquiries are being conducted by this
Bureau in this matter.

You may desire to advise the Department of State of
