PH 614-C-TE ADVISED ANGELO BRUNO CONFERRED WITH FRED IEZZI, FRANK NICOLETTI AND PAT MASSI APRIL 25. DETAILS OBTAINED AND BEING TRANSLATED. ADAM D'OTIO BORROWED \$500 FOR AN INDIVIDUAL, SHYLOCKING, WHO WILL REPAY BRUNO \$10 A WEEK. BRUNO INDICATED CURRENT RATE FOR SHYLOCKING IN HIS GROUP IS \$200 ON A THOUSAND EVERY SIX MONTHS.

PH 627-PC-TE MOVED TO A POSITION OF TRUST BY ACCOMPANYING JOHN COVELLI, AKA "ICE CREAM," DESCRIBED AS TRUSTED LIEUTENANT OF PHIL TESTA IN THE NUMBERS BUSINESS, TO NEW YORK APRIL 25, WHERE TESTA HELD MEETING WITH UNKNOWN INDIVIDUALS AT JACK DEMPSEY'S RESTAURANT. INFORMANT PLACED IN CHARGE NUMBERS BANK BEGINNING NEXT WEEK.

SPOT CHECKS VICINITY 9TH AND TASKER STREETS, PHILA MAINTAINED BY SAS THIS MORNING, WITH NEGATIVE RESULTS.
