MM 926-PC [redacted] advised on 5/1/65 that he has not heard from LES KRUSE or any of the Chicago associates of KRUSE, including RALPH PIERCE, and further, that his relationship with KRUSE has "cooled" considerably since the gambling arrangements he was negotiating with KRUSE in the Dominican Republic failed to materialize. Informant does not know of any travel by KRUSE or his associates to Santo Domingo during recent months.

MM 926-PC advised on 5/6/65 that HYMAN "RED" LARNER called him about three months ago and thereafter came to his, informant's, office in Miami for the purpose of looking into the possibility of purchase of 25 slot machines that the informant, and others, including KRUSE, have stored in the Hispanola Hotel, Santo Domingo. Informant asked LARNER to give him an offer, which was promised by LARNER, however,
