RESTAURANT FORMERLY FREQUENTED BY ALEX AND OTHER CHICAGO HOODLUMS HAS BEEN OUT OF BUSINESS FOR LITTLE OVER A MONTH. HE SAID HE RECENTLY LEARNED THAT MIKE FISH IS NOW IN BUSINESS WITH HIS BROTHER PETE FISH IN PETE FISH-S RESTAURANT LOCATED IN THE SAME NEIGHBORHOOD ABOUT TWO BLOCKS FROM MIKE FISH-S OLD LOCATION. PCI ALSO ADVISED HE HAS LEARNED THAT ALEX AND HIS ASSOCIATES NOW FREQUENT PETE FISH-S RESTAURANT AND HAVE BEEN DOING SO SINCE MIKE FISH HAS BEEN THERE.
