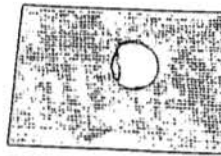

FRANK RAGANO, ATTORNEY, TAMPA, ADVISED OCTOBER 3 HE DECLINED TO FURNISH ANY INFORMATION REGARDING HIS CLIENT, SUBJECT, TO INCLUDE SANTO'S PRESENT WHEREABOUTS. HE INFERRED AT THE PRESENT TIME HE DID NOT HAVE KNOWLEDGE OF SUBJECT'S WHEREABOUTS. HE STATED HE HAD NOT SEEN SUBJECT RECENTLY. TP 41 PCI ADVISED OCTOBER 3 THAT CASIMIRO HERNANDEZ RETURNED TAMPA, SATURDAY, SEPTEMBER 30 AND NO INFORMATION HAS EMANATED FROM THIS SOURCE CONCERNING ANY MEETING WITH SUBJECT. [REDACTED] PCI, PROTECT, ADVISED OCTOBER 3 THAT FANO TRAFFICANTE, LIFELONG FRIEND, DECLINED TO INDICATE TO HIM SUBJECT'S WHEREABOUTS. PHYSICAL SURVEILLANCE SUBJECT'S TAMPA RESIDENCE AND OF JOE F.
