ROBERT EDWARD WEBSTER, INTERNAL SECURITY-R. CLEVELAND ORIGIN. MR. [] ADVISED CLEVELAND OFFICE THIS DATE THAT SUBJECT'S STORY HAS BEEN PICKED UP BY ASSOCIATED PRESS AND THE QUOTE CLEVELAND NEWS END QUOTE. HE HAS BEEN CONTACTED BY CLEVELAND REPRESENTATIVE OF AP AND CLEVELAND NEWS. AP SAYS STORY CAME FROM THEIR MOSCOW BUREAU. [] TAKING POSITION WITH PRESS THAT SUBJECT WAS EMPLOYEE BUT THAT RAND DEVELOPMENT CORP. HAS NO INFO CONCERNING HIS DEFECTION AND WILL MAKE NO STATEMENT UNTIL THEY HEAR FROM JAMES H. RAND WHO IS PRESENTLY IN MOSCOW. [] HAS BEEN IN CONTACT WITH SUBJECT'S WIFE AND SHE STATES THAT HER POSITION WILL BE THAT ALTHOUGH SUBJECT IS OVERDUE TO RETURN SHE HAS NO OFFICIAL INFO CONCERNING HIS ACTIVITY TO DATE. THE IDENTITY OF [] SHOULD BE CONCEALED IN ANY CORRESPONDENCE FOR DISSEMINATION.
