ANGELO BRUNO, AKA, AR. DAILY TELETYPE. PH 614-C-TE ADVISED BRUNO AND BEN GOLOB ACTIVE IN GETTING CIGARETTE VENDING MACHINE LOCATIONS FROM LOCATIONS HAVING CONTRACTS WITH OTHER VENDORS. SEVERAL MEANS USED TO GET OPERATORS TO BREAK CURRENT CONTRACTS. JOSEPH WILSON, ATTORNEY ACCOUNTANT, CAMDEN, NEW JERSEY, AT PENN JERSEY VENDING, FURNISHED BRUNO WITH COMPLETED INCOME TAX RETURNS FOR BOTH BRUNO AND WIFE SUE. BRUNO WORRIED ABOUT \$1500 ITEM AND HELD UP SUBMISSION PENDING FURTHER CHECK. CARL IPPOLITO, TRENTON HOOD, VISITED BRUNO APRIL 14, 1962. FRANK ANNARELLA PRESENTLY CARRYING CASH FOR BRUNO AND DISPENSES SAME WITH BRUNO'S APPROVAL. PH 623-C* CONFIRMED WILSON'S VISIT WITH BRUNO RE INCOME TAX MATTERS.
