CORU IS CONTINUING TO FORMULATE A PLAN TO KIDNAP A MEXICAN DIPLOMAT TO BE HELD AS A HOSTAGE TO FORCE THE MEXICAN GOVERNMENT TO RELEASE JAILED CORU MEMBERS, ORESTES RUIZ HERNANDEZ AND GASPAR EUGENIO JIMENEZ. NO DETAILS OF THAT PLAN ARE YET KNOWN. (S)(u) Mexico

VENEZUELAN AUTHORITIES HAVE SUCCEEDED IN EXPANDING CORU'S PROMISE TO REFRAIN FROM TERRORIST ACTIVITIES NOT ONLY IN VENEZUELAN TERRITORY BUT IN COSTA RICA AS WELL. IN EXCHANGE, CORU LEADERS WILL BE ALLOWED TO TRAVEL TO VENEZUELA FREELY TO SOLICIT MONETARY ASSISTANCE FROM CUBAN EXILES, BUT THEY ARE NOT TO UTILIZE THE COUNTRY AS A PLACE OF REFUGE OR A BASE OF OPERATIONS.
